TERMS AND CONDITIONS OF THE TENDER**I. ELIGIBILITY:**

- 1) The Contractor should have Registration with Regional Provident Fund Commissioner under provident Fund Act in the name of the firm in which tender is applied.
- 2) The Contractor should have registration with Employees State Insurance under the provisions of ESI Act in the name of the firm in which tender is applied.
- 3) The Contractor should have (a) Registered their establishment and (b) Should have obtained License from the labour Department, for having permitted to take up pest control contract works under the provisions of Labour Contract Act.
- 4) Contractor should have Goods and Service tax (GST) registration number obtained from sales Department and professional tax Registration No: obtained from commercial tax Department in the name of the firm.
- 5) The Contractor should have work experience for a minimum period of **three years** in providing pest control service in KMF units/KMF union Dairies or any other dairies.
- 6) The Contractor should have Financial statements and returns of Income for income tax Latest Assessment of three years 20-21, 21-22, 22-23
- 7) The Contractor Who Is Presently Engaged in Providing Contract Labours / Piece Work Contract to Shivamogga, Davanagere & Chitradurga District Co-Operative Milk Union and its units is not eligible to participate in this Tender.
- 8) Any Contractor who was engaged by the union for providing Security Service / Contract Labour Service / Any other Contract Service and whose contract was terminated during the said contract period or extended period due to non performance or breach of contract for any reason. Such contractors are not eligible to participate in the tender for a minimum period of **5** years from the date of termination of the contract.
- 9) Any contractor who has rendered / rendering any contract service to the union and whose services were / are considered as not satisfactory, with valid reasons such contractors are not eligible to participate in the tender. However the decision of the Managing Director in this regard shall be final & binding.
- 10) We are not providing any kind of transportation facilities for your pest control operators visiting for the treatment.
- 11) The contractors should upload their pest control license. (IPCA)
- 12) The contractors should upload the chemical name, composition and other details of chemicals used for pest control.
- 13) The contractors should mention the minimum number of employees/representatives, who visits sites for service.
- 14) The contractors may visit and inspect the sites at Dairies / chilling centers on his own cost before quoting the rates.
- 15) If the service found unsatisfactory, the contract can be terminated without prior notice.

II. Responsibilities of successive bidder on sites.

- 1) Agencies shall provide the services at Shivamogga dairy, Davanagere dairy & Five chilling centers
- 2) **A) Rodent control** : Includes strategic bait control & usage of glue boards. Roda boxes shall be numbered and fixed according to the bait map as per our requirement. Open area shall be treated with burrow treatment. Outside areas rodent shall be controlled by roda bait stations
B) Flying Insect Management: Preventive control shall be provided number of pesticide, chemical sprays shall be used in the production, packing and storage areas, chemical usage should not cause any harmful side effects to the operational staff and contaminate food by their order. Glue board shall be provided for fly catches once in 15 days or flow rate of insects. Trend analysis shall be conducted
C) Crawling Insect control: Crawling insects such as cockroaches, Ants, Millipedes etc crawling from outside the premises shall be suitable controlled.
D) Termal Fogging: On call basis twice a month
E) Disinfestation of packing machines:
Main dairy: (Milk, Curd, Ghee, Lassi & Buttermilk) 11 machines(22 heads) twice a month .
Davanagere dairy: Milk, Curd, Lassi & Buttermilk) 06 machines(12 heads) twice a Month.
F) Termite control: stores twice a month
G) Spider management:Inside plant area.
- 3) The service is to be carried out in the presence of our officials and shall obtain the signature from concerned section heads.
- 4) Documents such as standard operating procedures and MSDS for chemicals at the time of execution of work log sheets with details of area treated, pest found, action taken, pest control etc risk assessment copy shall be maintain to conform to the requirements of ISO 22000-2018 (FSSC)
- 5) Should furnish monthly trend analysis report and technical expert should be present during FSSC & Food safety audit
- 6) Should furnish Quarterly site audit report
- 7) The service technician shall have minimum qualification properly trained knowledge about pest control chemical and its application in dairy industries
- 8) Shall provide two services per month and pest eradicated at chilling centers.
- 9) Only approved brand of chemicals should be used. Contractor is responsible for consequences if any, occurred due to non approved brands.
- 10)Top most care and good supervision should be taken when the chemicals are applied near the production areas
- 11)The service technician or representative shall make entries at security section of main dairy, Davanagere dairy and all chilling centers that the chemicals or sprays or pest control accessories at the time of entering the premises
- 12)Your staff should report our Quality control division before starting the work & after finishing the work
- 13)Your staff must wear proper uniform and ID card issued by you
- 14)Chemicals used in pest controller should not impart any colour, odour, on any reaction on milk, milk products and packing materials and on the area of treatment such as walls, doors, windows and machineries.

- 15) Chemicals used should not be injurious to human health. Food grade certificates of chemicals should be uploaded.
- 16) Bait map layout has to be displayed at the entrance of respective dairies and chilling centers
- 17) Individual Medical certificate & Training certificate of the labour should be submitted to the office.
- 18) Every service should be started at early morning
- 19) Monthly pest control audit should be done and reports should be submitted to office
- 20) Records to be maintained for dead rodents and others
- 21) Pest Evaluation report should be submitted weekly to the QC after service
- 22) The frequencies of treatment should be as insisted, if any incident of failure the amount will be deducted correspondingly.
- 23) The contractors should ensure no pest left on site after treatment, if found in between two services, the additional service should be carried out free of cost.

III. CONTENTS OF TENDER DOCUMENTS:

The tenderer is expected to carefully examine all the instructions, terms and conditions in the tender document. Failure to comply with requirement of tender submission will be at tenderer's own risk. The tender which are not substantially responsive to the requirement of tender document and **which are conditional** shall be liable for rejection.

IV. CONTRACT PERIOD:

The contract shall be for a period of Two years from the date of commencement of the contract. However Managing Director, Shimul shall be reserved the rights to extend the contract period on same rate, terms & conditions for further period of 3 months or till the alternative arrangements are made whichever is earlier. However Managing Director, Shimul has also got the rights to terminate the contract in the interest of the Union at any point of time without giving any advance notice, depending on the exigency of the situation, during the contract period or extended period on breach of any contract conditions.

1. Tenderer shall furnish EMD as part of the tender for Rs. 40,000/- (Rupees Forty Thousand only) through e-Portal
2. The EMD of successful tenderer will be refunded when the tenderer execute the agreement and furnishes the required security deposit or adjust the same towards security deposit if the tenderer desires so.

VII. FORMAT FOR SIGNING THE TENDERS:

1. The tenderer shall prepare and submit the tender through E-procurement.
2. All the pages of tender document shall be signed & sealed by the tenderer. If any entries are to be amended / corrected they shall be written separately and legibly with the full signature of the tenderer and no overwriting shall be permitted.

- 1) Subject to the clause of the responsiveness, the Shimul will award the contract to the bidder whose tender has been determined to be substantially responsive to the tender document and who has been successful in clause **IX** mentioned above.

I. VALIDITY OF CONTRACT:

The validity of contract will be for a period of Two years from the date of commencement of the contract. SHIMUL reserves the right to extend the contract period on same rate, terms and conditions for further period of three months or till the alternate arrangements is made whichever is earlier. However Managing Director, Shimul has also got the rights to terminate the contract in the interest of the union at any point of time during the contract period or extended period without giving any advance notice depending of the exigency of the situation of breach of any contract conditions.

II. SECURITY DEPOSIT:

- 1) The successful contractor will have to deposit a security deposit of tender work order value of 5% for 24 months. The Security Deposit should be deposited in the form of Cash / D.D / Bank guarantee in favour of Managing Director, Shivamogga, Davanagere & Chitradurga District Co-operative Milk Union Ltd., within time prescribed in the tender acceptance letter.
- 2) No interest will be paid for the security deposit by the SHIMUL.
- 3) The security deposit will be liable for forfeiture fully or partly.
