- 6.2 Technical tender Part-I together with EMD OF Rs. 50,000/- and Commercial Tender Part-II duly completed shall be Upload in KPP portal only.
- 6.3 The Part-I Technical Tender shall be opened on the date/time and venue specified in Tender Notification in Presence of the tenderers or their authorized representatives who opt to be present during the Opening.
- 6.4 The Tenderer/ Tenderers representatives who are present at the time of Opening of tenders shall sign the Register evidencing the attendance.
- 6.5 The Technical Tender Part-I where in, the pre-qualification, based on eligibility of the tenderer will be evaluated, considered and decided prior to opening and consideration of COMMERCIAL TENDER PART-II of the Tender.
- 6.6 The COMMERCIAL TENDER Part-II of the tenderers who do not satisfy any/ all the terms and conditions specifically so mentioned under part-I Technical tender shall not be considered eligible and shall not be opened (as per the KPP portal)

- 7.4** If there is any discrepancy between words and figures the lowest among the two shall be considered and same shall be final.

## **8 EVALUATION OF TENDER.**

- 8.1** Taking in to consideration Technical competence and the quoted price, the tenders shall be evaluated as per the E-portal.
- 8.2** Not withstanding anything contained in the tender schedule, no obligation is cast on **SHIMUL** to accept the lowest tender and the union shall also reserves the right to accept or reject any or all the tenders without assigning any reason.

## **9. CRITERIA FOR AWARD OF CONTRACT:**

If any lowest Rate quoted tenderer for any reason fails to perform the insurance coverage effectively, the concerned tenderer shall be black listed and will not be allowed to participate in any of the subsequent tenders.

## **10. SHIMUL'S RIGHTS:**

SHIMUL reserves the right to accept or reject any one or all offers and to the tendering process at any time prior to award of contract, without thereby, incurring any liability to the effected tenderer or tenderers or any obligatory to inform the effected tenderers on the grounds of **SHIMUL action**.

## **11. NOTIFICATION OF AWARD:**

- 11.1** Prior to expiration of the validity of the tender the **SHIMUL** may notify the successful tenderers in writing by regd. Post/E-mail that its tender has been accepted as per the guidelines of the e-portal.
- 11.2** Notification of award shall constitute the formation of the Insurance coverage and a Memorandum of Understanding (M O U) should be executed on Bond Paper between **SHIMUL & Tenderer /Company**.

**TERMS AND CONDITIONS SPECIFIC TO SHIMUL**

1. Insurance companies who wish to submit tenders will have to participate by paying EMD of Rs.50,000/- and the EMD of the agreed rate insurance company will be taken as security deposit.
2. In 19 Taluks of **SHIMOGA, DAVANAGERE & CHITRADURGA Districts**, approximately 80,000 Pure Breed/Cross-Breed Cows /Heifers / Buffaloes are to be covered under Group cattle insurance policy.
3. The Pure Breed/Cross-Breed cows/Heifers/Buffaloes of the producer Member of the MPCS shall be covered.
4. Insurance company should quote the premium rate (inclusive of GST) for TWO YEARS, where the second year is considered as renewal and the union will pay premium amount for the renewal i.e, second year will be paid before the due date of the policy.
5. This cattle insurance tender is called for the period of two years. The premium rate quoted by the insurance companies will exists for two years.
6. The policy shall be for a period of one year from the date of receipt of Premium , Sum Assured for Pure Breed/Cross-Breed cows/Heifers/Buffaloes shall be covered up to Rs.80,000/- .
7. premium amount will be paid in advance by our end, as and when the animals covered under insurance in batches of three i.e, once in four months in a year.
8. 15 days waiting period will not be applicable. And risk coverage must be given from the date of premium amount paid.
9. The Insurance companies must supply Sufficient NDDB approved 12 digit plastic Ear Tags along with applicator and applicator pins.
10. The age limit shall have between 18 months to 8 years.
11. The Insurance shall not cover permanent total disability(PTD)
12. Conditions if any, under cattle insurance policy shall be furnished along with the premium rate.
13. The premium payment will be routed through the **SHIMOGA, DAVNAGERE & CHITRADURGA MILK UNION LIMITED**.
14. Group cattle insurance policy Covered Milk Producers Co-operative society only.
15. Company should generate issue insurance policy in soft and hard copy immediately after receiving concerned veterinary health certificate in correct way. If there is any correction in policy company has bounded to correct it.
16. The Claims shall be settled in the Name of the **ANIMAL OWNER ONLY**, and intimate the same to shimul on the same day of settlement.
17. Settlement of claimed amount in full to be made with in 15 days after the receipt of the complete documents.
18. Quarterly review meeting at **SHIMUL** shall be arranged to review the claim settlement, services etc.
19. The tenderer should have experience of handling Group cattle insurance, if so furnish the claims settlement details and premium quoted from your company.
20. The corrections if any should be attested by the tenderer.
21. While quoting the premium rates (inclusive of GST), service and tagging charges of Rs.10/- per animal to veterinary doctors must be included.

22. Immediate intimation of death of animal shall be done by farmer/area veterinarian to concerned insurance companies afterwards it is mandatory to insurance companies to register the same in their documents and they can inspect the location and animal within 12 hrs after intimation including government holidays. Failing which objection raised by insurance companies later for settlement of death claims cannot be entertained.
23. The valuation of animal mentioned in the insurance policy shall be the ultimate during death claim settlement and deduction under the same not entertained.
24. Managing Director **SHIMOGA, DAVANAGERE & CHITRADURGA** Milk Union Ltd., reserves the right to accept or reject the tender without assigning any reasons, thereof and also to award insurance company.
25. It is mandatory on the part of insurance companies to submit the fund utilization statement for the advance paid by shimul and cattle claim status report to the shimul every week.
26. All disputes are settled in the legal Jurisdiction of **SHIMOGA, DAVANAGERE & CHITRADURGA** Milk Union only.
27. Insurance company should have service branches in **SHIMOGA, DAVANAGERE & CHITRADURGA** Milk Union Jurisdiction.
28. Insurance Companies or their authorized brokers should be responsible for collection of cattle insurance proposals, policy coverage, re-tagging registration and timely settlement of claims etc.,

**SCOPE OF INSURANCE COVERAGE:**

The policy shall give indemnity only after death of cattle due to:

1. Accident (inclusive of Flood, Cyclone, and Famine) or any other fortuitous circumstances (fortuitous means accidental in origin.)
2. All diseased (inclusive of Rinder pest, black Quarter., Hemorrhagic Septicemia: Foot and Mouth disease Rabies etc.,
3. Surgical Operations.
4. Strike, Riot and civil Commotion risk and Terrorism.
5. Earthquake:

Contractor occurring during the period of Insurance subject to following **Exclusions:**

Death or loss due to:

- a. Malicious or will full act, negligence over loading, unskilled treatment, use of the animal other than stated in the policy without the consent of the company.
- b. Theft of clandestine sales, missing of insured animal.
- c. Partial disablement of any type, whether permanent or temporary.
- d. Permanent total disablement which in case of Milch cattle results in permanent and total in capacity to conceive or yield milk.
- e. War and other perils, Consequential loss of whatsoever nature.
- f. `No Tag- No Claim` is applicable here.
